## **Student Growth Waiver**

At the April 28, 2020 State Board of Education meeting, a <u>waiver</u> of student growth requirements associated with the evaluation cycle of tenured teachers was approved. A local school systems must work with local collective bargaining unit to modify their local evaluation models. Waiver implementations need to be reflected in data submitted for Teacher and Principal Evaluations for the 2019-2020 school year.

#### Modification to Data Collection Due to COVID-19

This year to accommodate the modifications caused by the school closures and the student growth waiver there are several data adjustments listed here.

- In-Person Observations: Numeric count of the observations completed in person.
- Virtual Observations: Numeric count of the observations completed virtually.
- Assignment of Effectiveness Rating (Highly Effective, Effective, Developing, and Ineffective): The following variables were created to capture the modifications to the effectiveness rating assignment.
  - Assignment of Professional Practice Rating
  - Assignment of Student Growth Rating
  - Assignment of Total Effectiveness Rating
    - All Components or Observations Completed Before Closure;
    - Completed All Components or Observations of Modified Model;
    - Completed One Observation and Used One from a Previous Year;
    - Previous Year's Rating;
    - Trend of Ratings:
    - Default Effective
- Student Growth Measures: Local school systems using an alternative student growth measure, must record the following; the type, points earned, and the percent of the model for the alternative measure. Report in the same manner as student learning objectives would be reported or other traditionally used student growth measures.
